#### Instructions

**GLOWET** can be used at room temperature. It can also be warmed at the microwave, being more comforting for the user. Do not heat up more than 30 seconds at 800W.

WARNING: Always check temperature before applying to the skin.

Pull slightly the removable tag and take out one glove, close the pack afterwards. Gently rub down the skin with the glove and let it dry. Throw away after using it. Do not flush it down the toilet.

#### Warnings and Recommendations

Keep out of the reach of children. Do not eat. External use. Do not apply on damaged skin, with wounds or ulcers. It is recommended to use several mittens for the same wash, according to the different areas of the body. Discard after use.
